INTRODUCTION

You can give permission for anyone interested in the LearningMethods work to have access to your material or you can restrict your permission only to LearningMethods Teachers or Apprentice-teachers who have signed a Licence Agreement that they will guard the confidentiality of the material and not share it with anyone else.
